In addition to compliance with the Data Protection Act, Omogolo Wildlife Trust is committed to the codes of conduct of the organisations it is accredited and certified by: Goede Doelen Nederland and Centraal Bureau Fondsenwerving.

THE DATA WE STORE

Omogolo Wildlife Trust only stores and uses data that we have obtained directly from you, via email, message, by post or by filling in the contact form on our website:

- Data necessary for communication with the donor: name, first names or initials, title (gender), address,
 zip code, email address, email contents and chosen project to support;
- Amounts of donations, needed to calculate the total amounts to be forwarded to the projects that we support.

HOW WE USE THIS DATA

We solely use the stored data for the following:

- To thank the donor and/or to confirm the donation by email
- To communicate with the donor if necessary, to clarify which project the donor wishes to support;
- To record the donations in our administration system;
- To deal with potential complaints or disputes;
- To analyse our fundraising activities;
- To allow for internal and external audits

The above actions result from the activities and obligations as described in the by-laws of Omogolo Wildlife Trust.

Omogolo Wildlife Trust never sells or distributes any personal data to third parties.

You have the right to see the data that is stored of you, to have it modified or removed.

All other data, from donors and projects that we support, is stored for the duration of the relationship with Omogolo Wildlife Trust and will be removed two years later.


